



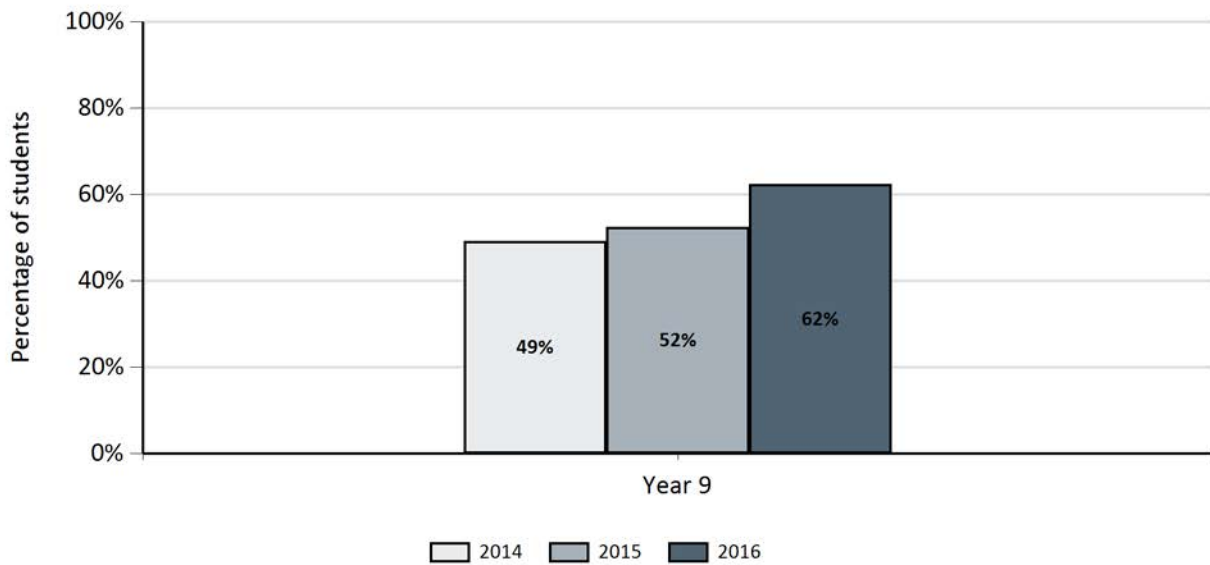

NAPLAN Proficiency

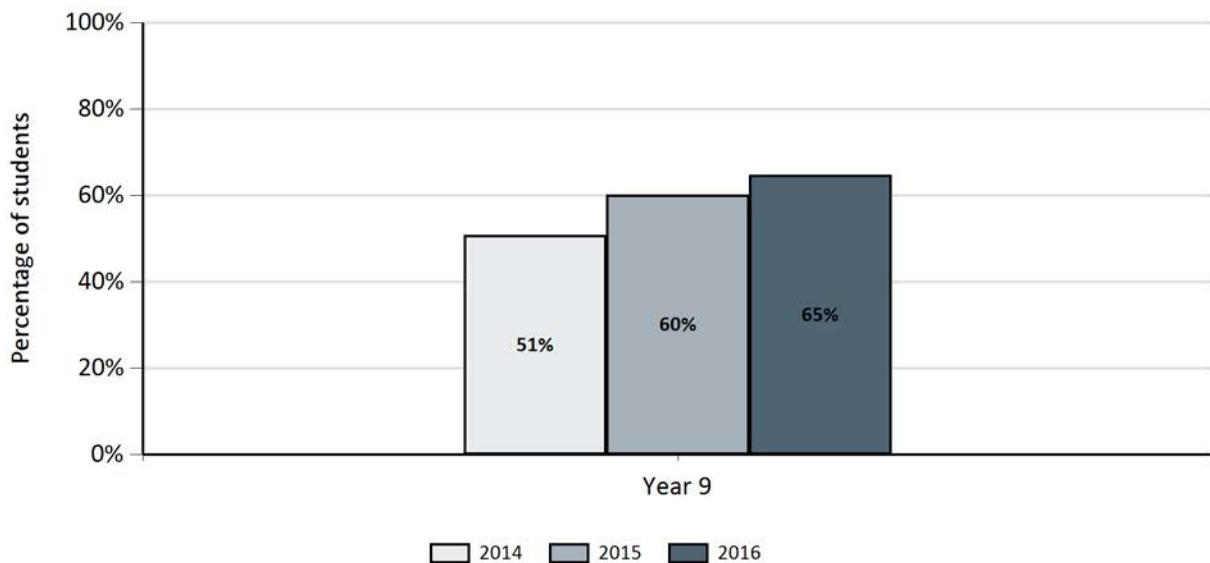
